Top-Ten Checklist Before Surrendering to Prison

1. Surrender Details:

- If you're surrendering to prison, you'd better make sure that you're ready. What do you need? First and foremost, ask your attorney to confirm that the receiving institution has all of your paperwork in order.
- Following your sentencing hearing, a process unfolds. The Judge will present a Judgment Order to the U.S. Marshal Service. The Probation Officer will forward the PSI to the U.S. Marshal Service. The U.S. Marshal Service will then forward the Judgment Order and the PSI to the Bureau of Prisons in Grand Prairie, Texas.
- BOP administrators in Grand Prairie Texas will then classify and designate the defendant to serve his or her sentence in a specific institution. They will issue a time for surrender.
- The defendant's attorney should work to ensure that the BOP in Grand Prairie has forwarded the appropriate paperwork to the receiving institution. If the receiving institution does not have the appropriate paperwork, administrators at the receiving institution will lock the prisoner in a solitary cell. The defendant may remain in that solitary cell for several weeks. In anticipation of this obstacle, the defendant should have a plan in place.
